HOUSING INITIATIVE GRANT – NEW CONSTRUCTION PACGDC Housing Initiative

Palo Alto County Gaming Development Corporation (PACGDC) has pledged funds for grants of up to \$20,000 for applicants who intend to purchase/construct a new single family personal residence in Palo Alto County. These grants will be awarded and administered by the City of West Bend An additional \$5,000 Demolition Grant may be awarded to be used solely for the demolition of any residential structure or any structure on city property deemed necessary to demolish by the City. A separate Demolition Grant application is required. **GRANT GUIDELINES:** Grants are only for the acquisition of a new (not previously occupied) primary personal residence/single family home within the City of West Bend, lowa, that was completed by 07-01-14 or after. The appraised value or actual cost of the home and land shall be between \$160,000 and \$400,000. Appliances shall not be included in the valuation. It is recommended to use local contractors whenever possible. An Applicant household may only be awarded a grant once in the life of the program. An Application may be denied for any reason. An Applicant must submit a completed application to the City of <u>West Bend</u> The City of ___West Bend _____ will issue a Grant Commitment to the Applicant and the Applicant's Lender. This Commitment is to be accepted in writing. If a Lender is involved, the Lender shall confirm an adequate construction or purchase loan commitment to the Participating City. When the City makes a grant commitment, it will so advise the Palo Alto County Gaming Development Corporation. Grant Commitments will be issued on a "first-come, first-served" basis, contingent upon approval by Palo Alto County Gaming Development Corporation, until funds are exhausted. The City is authorized to make application to Palo Alto County Gaming Development Corporation for \$20,000 to fund each application approved by the City. An Applicant may withdraw a Grant Application at any time prior to funds' disbursal. An appraisal must be completed prior to closing/disbursement of grant funds. Grant funds will be disbursed by the City of _____West Bend _____ to the Lender at the closing of the purchase or closing of permanent financing following completion of the newly constructed

residence, or to the Applicant upon occupancy if no Lender is involved.
